The Scelles Foundation is an independent, non-profit organization based in Paris (France) that **fights the system of prostitution** and the exploitation of prostituted persons, through information, analysis, advocacy, awareness initiatives and legal actions.

Our missions :

Knowing commercial sexual exploitation

We created an international Research Center responsible for collecting and producing information relating to commercial sexual exploitation in the world.

Understanding commercial sexual exploitation

Through multidisciplinary cooperation with experts (jurists, sociologists, police, NGOs), we publish analyses, books, articles and audiovisual documents.

Fighting commercial sexual exploitation

We lobby local, national and international elected officials. We engage in awareness and prevention activities. We organize conferences and participate in public debates and interviews with media.

OUR OBJECTIVES

The fundamental objective of the Scelles Foundation is to **drastically reduce the number of victims of the system of prostitution** by better **preventing, convincing major actors to act** and **insuring the implementation of exit options** for all prostituted persons.



To fight the global system of prostitution because it's a violation of human dignity and rights, a form of violence, an exploitation of the most vulnerable people, a major organized crime and an unacceptable trafficking of human beings.



To increase prevention & victims protection and support : decriminalization, paths to exit prostitution, reintegration, judicial actions.



To reinforce prosecution and punishment of perpetrators : to hold buyers accountable by sanctioning the purchase of sex acts, to strength the prevention and fight against pimping and human trafficking for the purpose of sexual exploitation.



To inform, advise, educate and raise awareness among the public especially the youth and decision makers in order to promote the abolitionist system and to take actions against the system of prostitution

INTERNATIONAL OBSERVATORY

Since its creation, the Scelles Foundation has developed an **International Research and Documentation Center on sexual exploitation**, otherwise known as **CRIDES**, unparalleled in Europe, in order to fight the system of prostitution.

Its objectives are:

1. To inform & raise awareness given the lack of information and interest observed within the general public and public authorities for the fight against prostitution and human trafficking;

2. To analyze all the aspects of sexual exploitation (prostitution, sex tourism, pimping, procuring, child pornography, human trafficking for commercial sexual exploitation, etc.) and provide high quality information;

3. To fight sexual exploitation by providing potential solutions and encouraging actions to reduce prostitution and human trafficking worldwide.

CRIDES is organized around 3 main types of activities :

DOCUMENTATION:

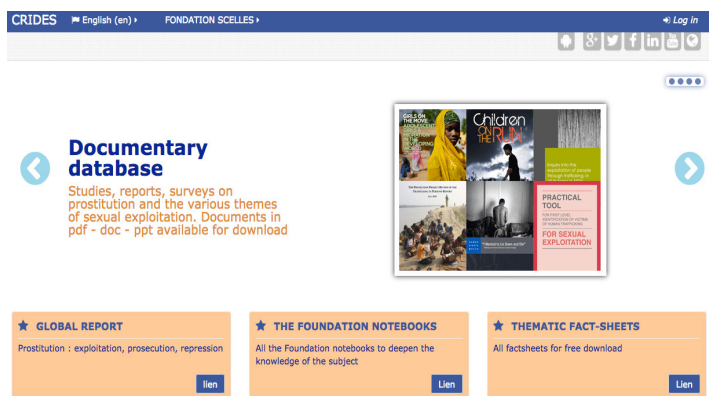
Evaluation reports, manuals for practitioners, legal texts, policy analyses, strategies elements, national action plans, good and innovative practices, advocacy. The Scelles Foundation now stores more than 10,000 international documents, 3,000 global studies and reports, 500 books and 107 documentaries from many countries, which are all available online for free.

RESEARCH, ANALYSIS & PROPOSALS

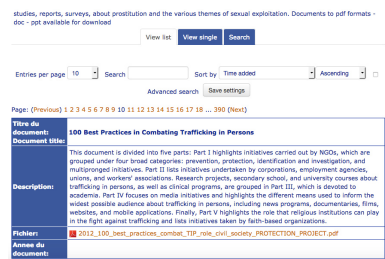

YOUTH ENGAGED WITH US

Launched in 2012, the annually **Scelles Foundation Awards** has rewarded lots of youths involved in the fight against prostitution and human trafficking.

This initiative is the result of **strong partnerships between the Scelles Foundation** and **Ecole Nationale supérieure Louis Lumière** (French Louis Lumière national high school of cinema, pictures and sound for the **Best Visual**), **ENM** (French national high school for magistrates for the **Best Indictment**), **ESJ** (French graduate school of journalism for the **Best Report**), « **La Conférence** » (group of the best young lawyers of the Paris Bar for the **Best Pleading**), and some high schools in Ile-de-France and Paris, with the French slam performer **Dialem** (for the **Best Slam**), **Faculté de médecine Paris Descartes** and **Action-Santé-Femmes** (Faculty of Medicine, Paris and Women health association for the **Best Medical Speech**).

Students and young professionals (journalists, lawyers, magistrates, photographers, medical experts) take up the challenge to illustrate the violent reality of prostitution through their various fields of expertise and understanding of the phenomenon. For each discipline, the most talented participants can be rewarded during a Ceremony in the Paris Bar Library surrounded by both their peers and distinguished personalities. The Scelles Foundation grants 2 prizes, the **Public Award** (online public polls) and the **Jury Award** judged by legal, political and media personalities.



LEGAL & JUDICIAL DEPARTMENT

The Scelles Foundation has created a legal department in charge of **monitoring the new France's law** against prostitution, and **developing judicial actions** in relation to the institutions concerned in France and abroad (Justice, police, organizations responsible for victims, etc...).

In the framework of these partnerships, the Scelles Foundation will organize **trainings for main actors** involved in the fight against the system of prostitution. It will also provide **units and materials for awareness raising** to prevent the purchase of sexual acts.

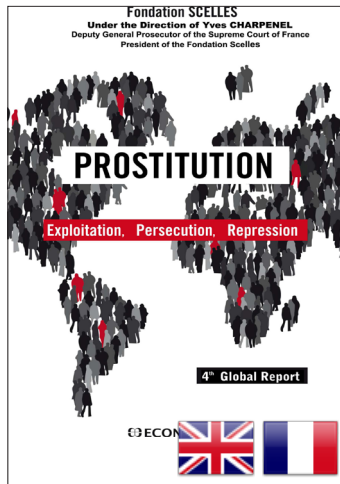

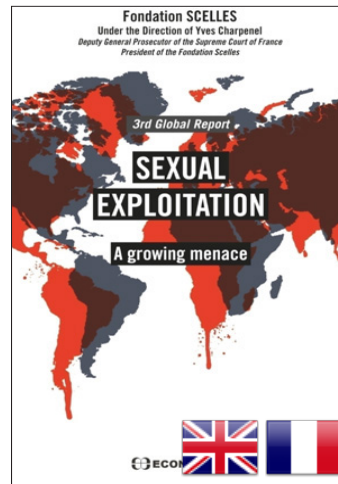
« Prostitution : Exploitation, Persecution, Repression »

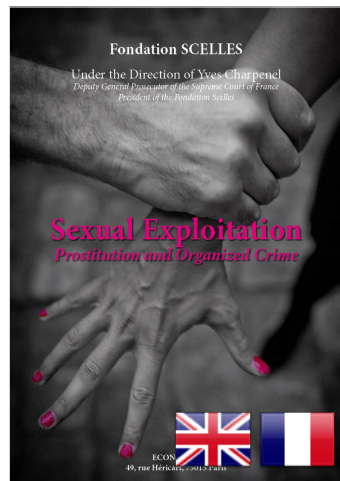
« Sexual Exploitation: a Growing Menace »

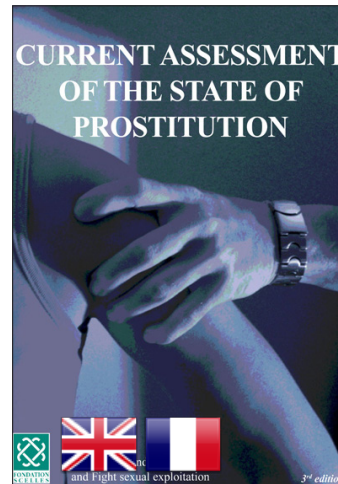
« Sexual Exploitation: Prostitution and Organized Crime »

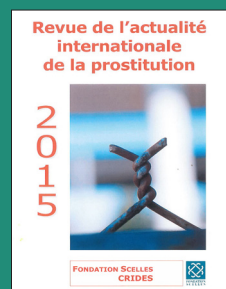

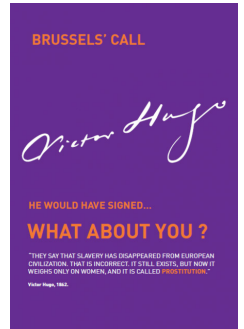
« International News on Prostitution » Press reviews and annual compilation

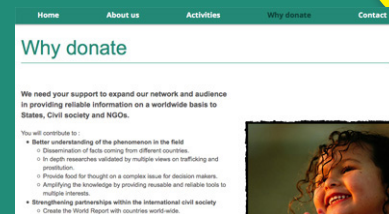

ARTICLE 7

Considering that prostituted people are essentially all women and that clients are almost entirely men, thus violating the principle of gender equality:

1. We reaffirm the abolitionist position of France, the objective of which is ultimately a society without prostitution
2. We proclaim that the notion of irrepressible sexual needs rests on an archaic concept of sexuality that does not legitimize prostitution, nor does it justify sexual assault.

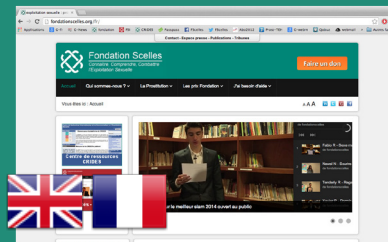

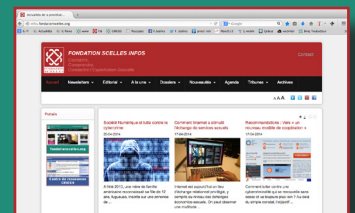
